

This language proficiency examination certifies that candidates have acquired very basic German language skills and corresponds to the first level (A1) on the six-level scale of competence laid down in the Common European Framework of Reference for Languages (CEFR).


In this regard, the DepEd, through the BCD-Special Curricular Programs Division, encourages **Grade 10 SPFL-German learners** from schools listed in Annex A to take the Goethe-Zertifikat: Fit in Deutsch 1 examination on the designated schedule. school's MOOE and other local funds, subject to the usual accounting and auditing rules and regulations. To ensure the safety of learners, the school should provide a transportation service to all learners who will take the examinations.

This Office interposes no objection on the participation of the learners provided that time-on-task policy shall be observed based on **DepEd Order No. 9, s. 2005 to ensure that learning shall not be disrupted and continued for the benefit of the learners.** In addition, the travel authority of the learners and/or accompanying teachers shall be on the discretion of the school heads and the schools division superintendents as stipulated in DepEd Order No. 1, s. 2023.

SPFL-German teachers of learners who will take the test shall accomplish the attached registration form (Annex B). Parents of learner shall also accomplish the Parent Consent (Annex C) form. Both forms shall be submitted through email at erwin.dionisio@deped.gov.ph on or before the deadline.
