The Bureau of Learners Support Services – School Health Division (BLSS-SHD) is developing the Manual of Procedures (MOP) for School Clinics that will serve as the standard and basis in the implementation of the programs and projects under the *Oplan Kalusugan sa DepEd* (OKD), specifically in the medical, nursing, dental and nutrition services.
