Chinese teachers from March 15-17, 2024 at the Angeles University Foundation, Angeles City, Pampanga.

The proficiency test aims to assess the Chinese language proficiency of the non-native Chinese teachers and is a requirement for all SPFL-Chinese teachers taking the Master of Arts in Education major in Chinese Language Teaching (MAEd CLT).

Kindly refer to Annex A for the list of test-takers. The test fee and accommodation shall be shouldered by the Confucius Institute at Angeles University Foundation while the travelling expenses shall be charged against school's MOOE and other local funds, subject to the usual accounting and auditing rules and regulations.

Time-on-task policy shall be observed based on **DepEd Order No. 9, s. 2005 to ensure that learning shall not be disrupted and continued for the benefit of the learners. In particular, there shall be relieving teachers to handle the classes of the teacher-participants.** In addition, the travel authority of the teachers shall be on the discretion of the school heads and the schools division superintendents as stipulated in DepEd Order No. 1, s. 2023.
