Pursuant to the Philippines' international commitment as a member of the ASEAN Schools Sports Council, the Philippines, through the Department of Education (DepEd) will participate in the 13th ASEAN Schools Games (ASG) scheduled from May 31 to June 9, 2023 in Da Nang, Vietnam.

The ASG is an annual sports competition organized under the ASSC and participated in by secondary school students from its ten (10) member-countries. Its aim is to promote ASEAN solidarity in our youth through school sports and provide opportunities for student-athletes to benchmark their sporting talents. ASG also serves as a venue to interact and engage in cultural exchange within ASEAN counterparts.

To ensure the effective selection of the best and finest student-athletes, specifically for athletics and swimming, the Bureau of Learner Support Services – School Sports Division (BLSS-SSD) intends to conduct a **National Try-Out Invitation for Athletics and Swimming for the 13th ASG** from **April 9-11, 2024**, at PHILSPORTS Ultra Track and Field Oval and Swimming pool, Pasig City.

Participants for athletics shall be billeted at NEAP, Marikina City, while swimming participants shall be housed in the DepEd PASS Dormitory, DepEd Complex, Meralco Avenue, Pasig City.

The National Try-Out Invitation shall be extended to all student-athletes from across the 17 regions who will meet the qualifying standards based on the 2019 ASG podium finish results for Athletics and Swimming. The qualifications for the participating student-athletes and other related information are contained in the enclosed *General*

All concerned are enjoined to authorize the participation of the identified student-athletes and DepEd personnel to the National Try-Out Invitation, as contained in the enclosed *List of Participating Student-Athletes, Technical Officials, and Members of Various Working Committees to the National Try-Out Invitation for Athletics and Swimming for the 13th ASG.*

DepEd teaching personnel who will serve as technical officials during the said activity shall be entitled to service credits in accordance to DepEd Order (DO) No. 53, s. 2003 entitled *Updated Guidelines on Grant of Vacation Service Credits to Teachers.*

In observance of and in compliance to DepEd Order No. 34, s. 2022 entitled *School Calendar and Activities for the School Year 2022-2023*, the concerned schools division offices, through the school heads shall ensure that a substitute teacher will take over the classes in the absence of their respective teaching personnel who will participate to the National Try-Out Invitation to prevent disruption of classes.

Expenses to be incurred for food and accommodation of participants, including travel expenses of technical officials, school sports selection group and members of the working committees shall be charged against the 2023 Physical Fitness and School Sports (PFSS) continuing funds while the traveling expenses of the delegation (regional and division sports officials, student-athletes, coaches/chaperons, etc.) shall be charged against their respective local funds, subject to the usual accounting and auditing rules and regulations.
