The Google Meet link and passcode shall be sent through the respective email addresses of all NLC Regional Coordinators not later than March 11, 2024.



To support the implementation of the National Learning Camp (NLC and the other End-of-School Year (EOSY) break activities in 2023, Program Support Funds (PSF) from two sources — Basic Education Curriculum (BEC) and General Management and Supervision— Maintenance and Other Operating (GMS-MOOE) Funds were downloaded to regional offices (ROs) with corresponding guidelines to provide direction for its utilization.

In light of the upcoming 2024 NLC and other EOSY break activities, this office reiterates the provision on the utilization of excess funds as stipulated in OUCT-OUF Joint Memorandum on the Guidelines on the Utilization of the 2023 Program Support Funds (PSF) to the Regional Offices (ROs) for the Implementation of the National Learning Camp (NLC) and Other EOSY Break Activities Supporting the National Learning Recovery Program (NLRP) dated November 13, 2023, viz: "The excess funds of the NLC PSF charged to the 2023 GMS-MOOE shall only be used for the payment of meal expenses for the forthcoming NLC and Other EOSY Break Activities for SY 2023-2024".

The attached report, dated February 29, 2024, shows the total amount generated as savings by each RO from the unutilized PSF. These savings shall form part of the total PSF earmarked for the implementation of NLC & other EOSY break activities 2024. These funds shall be supplemented by the BEC 2024 Current Funds to be downloaded to the regions prior to the implementation of the NLC and other EOSY break activities from July 1 to 19, 2024.
