

Relative to **DM-CT-2024-053** or **2024 Training Programs for Special Program in Foreign Language (SPFL)-Spanish Teachers Facilitated by SPFL-Spanish Program Partner (Ministry of Education, Vocational Training and Sports of the Kingdom of Spain, through the Embassy of Spain to the Philippines)**, dated February 23, 2024, the Department of Education, through the Bureau of Curriculum Development-Special Curricular Programs Division, announces the conduct of the **Online Diagnostic Test for the EUROPROF Teacher Training Program on March 22, 2024.**

The EUROPROF Teacher Training Program, organized and funded by the Spanish Ministry of Education, Vocational Training and Sports, and Instituto Cervantes Manila, is intended for teachers with either A1 or A2 Spanish language proficiency level. As there are limited slots for the training program, Instituto Cervantes and the Education Office of the Spanish Embassy will start the selection process by setting a diagnostic test to identify and validate the proficiency level of SPFL-Spanish teachers who applied for the program.

In this regard, SPFL-Spanish teachers who applied for the program are directed to take the diagnostic test on March 22, 2024 between 1:00 p.m and 5:00 p.m. The test

will last for about **20 minutes**, but the teacher may have to wait for their turn for a maximum of one hour.

The participation of the teachers shall follow time-on-task policy based on DepEd No. 9, s. 2005 titled *Instituting Measures to Increase Engaged Time-On-Tasks and Ensuring Compliance Therewith* to ensure that learning shall not be disrupted and continued for the benefit of the learners.
