1. The Department of Education (DepEd), through the Bureau of Education Assessment (BEA), will administer the **Programme for International Student Assessment (PISA) 2025 Field Trial**, pursuant to DepEd Order No. 29, s. 2017 titled, Policy Guidelines on System Assessment in the K to 12 Basic Education Program.
2. The goal of PISA is to evaluate education systems worldwide by testing the skills and knowledge of 15-year-old students who are approaching the end of their compulsory education. PISA tests how students can apply their knowledge and skills to real-life situations and problems, rather than testing their knowledge recall. The three core domains of PISA are Reading Literacy, Scientific Literacy, and Mathematical Literacy. In PISA 2025, **the major domain of assessment is Science.**
3. The PISA 2025 Field Trial in the Philippines will be administered as a Computer-based Assessment (CBA) from **April 15 to May 10, 2024.**
4. The list of the sample schools and test schedules are communicated directly to the concerned regional offices and school division offices to maintain the confidentiality and anonymity of the participants.
