

**CONTRACT FOR THE SUPPLY AND DOOR-TO-DOOR DELIVERY OF
 SUPPLEMENTARY LEARNING RESOURCES (SLRs) FOR LOT 2**

KNOW ALL MEN BY THESE PRESENTS:

This Contract is entered into by and between:

Department of Education – National Capital Region, with office address at Misamis St., Bago Bantay, Quezon City herein represented by **JOCELYN DR. ANDAYA**, Director IV, and hereinafter referred to as the **PROCURING ENTITY**,

-and-

LAMPARA PUBLISHING HOUSE, INC. a private entity with office address at 183 Sgt. Rivera Street, San Francisco Del Monte, Brgy. Manresa, Quezon City represented by **CARLO BUNAYOS**, Sales Director and hereinafter referred to as the **SUPPLIER**, collectively, the **“Parties”**.

W I T N E S S E T H:

WHEREAS, DepEd Central Office downloaded funds per Sub-ARO No. OSEC-NCR-23-5892 dated October 24, 2023 for the procurement of SLRs for Library Hubs and the invitation to bid for the supply and door-door delivery of SLRs was posted on November 17, 2023;

WHEREAS, three prospective bidders namely: Adarna House, Inc., HRRP Enterprise and Lampara Publishing House, Inc submitted their bid proposals for Lot 2 within the deadline of submission on December 13, 2023;

WHEREAS, Adarna House, Inc. and HRRP Enterprise were declared failed during the opening of bids on December 13, 2023 while Lampara Publishing House submitted a bid in the amount of Php13,934,237.50;

WHEREAS, the motion for reconsideration of Adarna House, Inc. was denied per BAC Resolution No. 94, s. 2023 while HRRP Enterprise was granted per BAC Resolution No. 93, s. 2023. However, during the opening of the bid of HRRP Enterprise for Lot 2 on December 27, 2023, it was declared failed. The bid of Lampara Publishing House, Inc. was declared the lowest calculated bid for Lot 2;

WHEREAS, per post-qualification evaluation, it was found out that SUPPLIER is compliant with requirements. Pursuant thereto, the Bids and Awards Committee (BAC), recommended to the Regional Director, as Head of the Procuring Entity, the approval of award of contract to the **SUPPLIER** per BAC Resolution No. 100, s. 2023 dated December 28, 2023.

NOW, THEREFORE, in consideration of the foregoing premises and of the mutual covenants and undertaking set forth, the parties have agreed, as follows:

ARTICLE 1. OBLIGATION OF THE SUPPLIER. That, the SUPPLIER shall supply and door-to-door deliver the SLRs to the fifteen (15) Library Hubs of DepEd NCR within **forty-five (45) days** period from the receipt of the Notice to Proceed (NTP).

ARTICLE 2 - CONTRACT PRICE. The contract price is **Thirteen Million Nine Hundred Thirty-Four Thousand Two Hundred Thirty-Seven Pesos and Fifty Centavos (Php13,934,237.50)**. The **Procuring Entity** shall pay the full payment of the contract price after complete delivery of SLRs to recipient Library Hubs and upon submission of billing statement and other necessary documents, subject to the usual accounting and auditing rules and regulations;

ARTICLE 3 - LIQUIDATED DAMAGES. In case of delay in the performance of its obligation, the SUPPLIER shall be liable to pay the PROCURING ENTITY liquidated damages at the applicable rate of one tenth (1/10) of one (1) percent of the cost of the unperformed portion for every day of delay until actual complete delivery or performance pursuant to GPPB resolution No. 02-2020. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of this Contract, the PROCURING ENTITY shall rescind this Contract, without prejudice to other courses of action and remedies open to it.

ARTICLE 4. TAXES. Taxes shall be for the account of the SUPPLIER and deemed to have been included in the bid proposal. No request for revision of prices and claims by the SUPPLIER that such taxes or duties were not included in the bid price for any reason whatsoever shall be entertained.

ARTICLE 5. ADDITIONAL PROVISIONS. The SUPPLIER warrants that it has not given nor promised to give any money, gift or favor to any officials or employees of the PROCURING ENTITY to secure this CONTRACT and any violation of this warranty shall be sufficient ground for the revocation or cancellation of this CONTRACT.

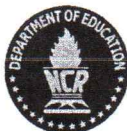
