WHEREAS, the BAC recommended award of contract to the **Second Party** per BAC Resolution No. 33, s. 2024 and a Notice of Award was issued on April 4, 2024;

NOW, THEREFORE, in consideration of the foregoing premises and of the mutual covenants and undertaking set forth, the parties have agreed, as follows:

1. That, the **Second Party** shall provide unto the **First Party** the following packages, to wit:

a. Regional Training of Division Trainers and School Leaders on the MATATAG Curriculum on April 8-12, 2024 (Batch 1) and April 15-19, 2024 (Batch 2) with 340 (Batch 1) and 339 (Batch 2) participants and guaranteed 80% participants.

b. The following are the approved specifications:

- Preferably within Tanza, Cavite
- With Plenary Hall good for 340 participants
- With 9 breakout rooms with 1 projector and whiteboard per breakaway room - can accommodate 37 pax
- 3 Single beds per room, no sharing of bed
- With provision for parking
- With overflowing coffee
- With strong internet connection

- The service supplier shall provide a vegetarian offer.
 - The service supplier shall eliminate the use of non-essential disposable products like plastic bags, single-use utensils, etc. When disposable products are used, the supplier shall use recycled materials where possible.
 - The service supplier shall ensure that indoor lighting is energy efficient.
 - The service supplier shall reduce packaging and usage of disposable containers for food, drink and condiments.
 - The service supplier shall post its environmental policies or targets in places where guests and employees can easily notice them.
2. The **First Party** shall pay the **Second Party** in consideration for the full and faithful performance of its obligations the total amount of **Six Million Seven Hundred Twenty-Two Thousand One Hundred Pesos (Php6,722,100.00)**.
 3. That for and in consideration of the services rendered by the **Second Party**, the **First Party** shall pay the full payment of the contract price after the event, upon submission of billing statement and other necessary documents, subject to the usual accounting and auditing rules and regulations;
 4. Notwithstanding the foregoing payment shall be based on actual attendance of participants.
 5. Taxes shall be for the account of the **Second Party** and deemed to have been included in the bid proposal. No request for revision of prices and claims by the **Second Party** that such taxes or duties were not included in the bid price for any reason whatsoever shall be entertained.
 6. This Contract shall take effect upon signing thereof by the parties.
