The Learner Rights and Protection Office (LRPO) is mandated to serve as the lead office of the Department of Education in implementing activities, including intervention mechanisms, related to learner rights and protection at different governance levels of the DepEd, pursuant to DepEd Order No. 003, s. 2021. Under the aforementioned DepEd Order, the LRPO is also mandated to initiate and coordinate cooperation or partnership activities with other national government organizations, among others, in the implementation of child protection.

In line with the foregoing mandates of this Office, the main goal of this activity is to improve the referral systems in schools for learner rights and protection cases. This is also consistent with the directive of the Vice President and Secretary of Education during her Basic Education Report 2024 to improve preventive and responsive mechanisms, and to strengthen learners' helpdesks in schools.

The Workshop for the Mapping of Intervention Providers for the Referral System on Learner Rights and Protection shall be conducted with the following objectives:


- a. Increase the number of resolved incidents reported;
- b. Map intervention providers per School Division Offices;
- c. Particularize referral systems; and
- d. Decrease the cases that were settled amicably.




Identified Regional and Schools Division Focal Persons of LRPO are requested to attend and participate in the aforementioned workshop. The identified focal persons






