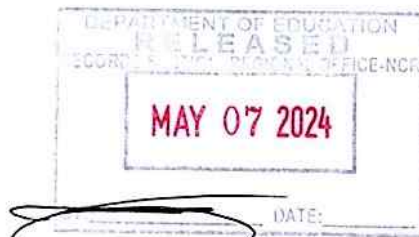

Based on the Dengue Morbidity Week 12 Report of the Regional Epidemiology Surveillance Unit (RESU) of the Department of Health- Metro Manila Center for Health Development (DOH-MMCHD), there were 4,198 cases reported at the different reporting units of the National Capital Region (NCR) from January 1 to March 23, 2024. This is 5% higher than the five-year average from 2018, 2020-2023 and majority of cases belong to 5-9 years age-group which consists mainly of school-age children.

With the advent of the rainy season, the National Aedes-borne Viral Diseases Prevention and Control Program (NAVDPCP) of the DOH-MMCHD in collaboration with the Quezon City Health Department will implement Integrated Vector Control (IVC) activities in all public elementary schools in the National Capital Region.

The IVC aims to prevent dengue transmission among school-aged children during the start of school year. This will be integrated in the Brigada Eskwela Program scheduled on July 24, 2024 at Esteban Abada Elementary School in Quezon City.

In this regard, may we request your presence during the above-named activity and deliver a message of support. Furthermore, may we also request your approval for the following personnel to join the activity.


