CONDUCT OF REGIONAL EDUCATION SUMMIT FOR PRIVATE SCHOOLS 2024

1. In view of the **Regulatory and Developmental Services to Schools** as one of the Key Result Areas (KRAs) of the Quality Assurance Division (QAD), the **Regional Education Summit for Private Schools** is scheduled on **May 24, 2024 (Friday)** from **8:30 AM to 4:30 PM**, at a venue to be announced.
2. This engagement aims to provide a platform for administrators of private schools to collaborate with DepEd education officials keeping them abreast with the latest guidelines and regulations affecting the operation of private schools upholding the delivery of high-quality basic education.
