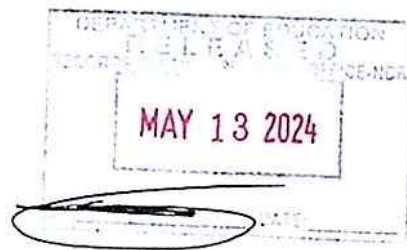

Pursuant to Memorandum DM-OUCT-2024-097, "Specific Guidelines for the Effective Implementation of the National Learning Camp and Other Activities for the 2024 End-of-School-Year (EOSY) Break", this office announces the upcoming activity titled "**Capacitating Supervisors for Effective Implementation of the National Learning Camp (NLC)**," scheduled for **May 20-22, 2024**, in the Cavite City area.
