

REGIONAL ORIENTATION FOR SCHOOL MENTAL HEALTH COORDINATORS AND CO-COORDINATORS AND GUIDANCE COUNSELOR/DESIGNATES FOR MENTAL HEALTH BASIC SERVICE DELIVERY IN SCHOOLS

1. The Education Support Services Division- School Health and Nutrition Unit (ESSD-SHNU) of DepEd NCR will be conducting an Orientation for School Mental Health Program Coordinators and alternates and Guidance Counselors/Designates for Mental Health Basic Service delivery in Schools on June 19, 2024 from 8 am to 5 pm at DepEd NCR Conference Room.
