NOW, THEREFORE, in consideration of the foregoing premises and of the mutual covenants and undertaking set forth, the parties have agreed, as follows:

- 1. That, the **Second Party** shall provide unto the **First Party** the following packages, to wit:
 - a. Venue & accommodation for the PRIME Synergy Private Schools Summit 2024 of DepEd NCR to be conducted on May 24, 2024 with approximately 1,000 participants and guaranteed 80% participants.
 - b. With Day 0 board & lodging for 28 participants
 - c. The following are the approved technical specifications:
 - Preferably within NCR
 - Provision of venue for 1,000 participants
 - With two (2) snacks and lunch
 - Provision of board & lodging for Day 0 of QAD RO Personnel
 - Four (4) spare rooms for break-out sessions
 - Provision of parking
 - With overflowing coffee
 - With internet connection
 - LED wall for projection
 - Program invitation
 - At least 80% guaranteed participants or actual attendees

Green Procurement Specifications

- Service Provider shall have its own environmental policy such as reduction of waste and energy consumption, and water saving.
- Service Provider shall provide a vegetarian and non-meat offer
- Service Provider also eliminate the usage of non-essential disposable products like plastic bags, single-use utensils, etc.
- Indoor lighting must energy efficient
- The service supplier shall provide local or regional products or products which are produced in a sustainable way (e.g. produced according to good agriculture practices, organic, avoiding overfishing, no products from threatened species) when offering food and beverages.
- The service supplier shall reduce packaging and usage of disposable containers for food, drink and condiments.

- 2. The First Party shall pay the Second Party in consideration for the full and faithful performance of its obligations the total amount of One Million Two Hundred Forty-Six Thousand (Php1,246,000.00).
- 3. That for and in consideration of the services rendered Second Party, the First Party shall pay the full payment of the contract price after the event, upon submission of billing statement and other necessary documents, subject to the usual accounting and auditing rules and regulations;
- 4. Notwithstanding the foregoing payment shall be based on actual attendance of participants.
- 5. Taxes shall be for the account of the Second Party and deemed to have been included in the bid proposal. No request for revision of prices and claims by the Second Party that such taxes or duties were not included in the bid price for any reason whatsoever shall be entertained.
- 6. This Contract shall take effect upon signing thereof by the parties.
