The Commission on Higher Education - National Capital Region (CHED-NCR) is pleased to announce that the call for applications to the CHED Merit Scholarship Programs (CMSPs) with **96 new slots only** for incoming college freshmen in NCR for Academic Year (AY) 2024-2025 is open **until July 15, 2024**.

Interested **incoming first-year college students** can submit their applications to CHED-NCR via ONLINE through this link: https://bit.ly/CMSPApplication_CHEDE-NCR.

Student-applicants must be enrolled in any of the identified undergraduate priority programs, in CHED recognized higher education institution, pursuant to CHED Memorandum Order (CMO) No. 7, s. 2023; CMO No. 10, s. 2023; and, Memorandum from the Chairperson on GAD StuFAPs Allocation. Eligibility requirements are as follows:

1. Filipino Citizen;
2. Graduating high school student/High school graduate with general weighted average (GWA) of at least 93%; and
3. Combined ANNUAL GROSS INCOME of parent/s, guardian which **DOES NOT EXCEED** four hundred thousand pesos (PhP400,000.00) or in cases where the income exceeds PhP400,000.00, with family member with medical illness or with two or more dependents enrolled in college.

In view of the foregoing, we would like to request for your assistance in disseminating this call for application to prospective student-applicants.

Student applicants who fulfill the requirements shall be ranked and selected based on the above eligibility and other documentary requirements stipulated in CHED Memorandum Order (CMO) No. 8, series of 2019 and CMO No. 11, series of 2021. Application is subject to the availability of slots/funds.
