

Warm greetings from ABC+!

Over the last four years, the United States Agency for International Development (USAID) Philippines, through the ABC+: Advancing Basic Education Project in the Philippines, has worked together with the Department of Education and education partners in improving education outcomes in the Philippines. This partnership has made significant results and progress towards contributing to the goals of DepEd.

At the core of our collaborative approach lies the Education Sector Mechanism (ESM), which serves as a framework for coordination and collaboration among various education stakeholders, including DepEd, local government units (LGUs), civil society organizations (CSOs), and the private sector. Through the ESM, we aim to leverage our collective resources and expertise to enhance the quality of early grade education in your region.

As part of our ongoing efforts to expand our reach and deepen our impact, we are eager to engage with DepEd Regional Office of NCR to explore collaboration opportunities. Initially, the project would want to work on 3 Schools Division Offices, namely, SDO Malabon, SDO Marikina and SDO Pasig. By working together, we believe we can address key challenges in the education sector and create lasting positive change for early grade learners in NCR.

During the meeting, we would like to:

- Introduce the ABC+ Project and its goals, objectives, and areas of intervention.
- Discuss the Education Sector Mechanism (ESM) and its role as a collaborative platform for engaging local education stakeholders.
- Explore potential collaboration opportunities between DepEd NCR SDOs and the ABC+ Project through the ESM, including engagement with LGUs, CSOs, and the private sector.
- Identify other priority areas for collaboration and discuss potential joint activities and initiatives aligned with DepEd's strategic objectives including areas where we could work together in strengthening instructional delivery and in developing appropriate materials for early grade learners.
