
- 1. As part of the requirements of the Linking Standards and Quality Practice (LiSQuP) program, PhD or doctoral scholars who are enrolled in DC 808 (Internship in School Counseling) are required to successfully complete a 300-hour online practicum/internship from 03 June to 29 August 2024.
- The counselor-in-training is expected to undergo supervised online training in the conduct of the following:
 - a. Individual counseling (including crisis intervention);
 - b. Group counseling;
 - c. Guidance curriculum/homeroom guidance (e.g., guidance lessons and school-wide projects addressing learners' needs related to placement whether for career or education);
 - d. Counseling for special needs;
 - e. Counseling in relation to multicultural backgrounds in a diversity-acknowledged school environment;

- Consultation (with parents, school personnel, etc.);
- Appraisal (e.g., testing, g. needs assessment);
- Referral; h.
- Record keeping; i.
- Professional development; j.
- Program management; and k.
- 1. Other relevant team duties.












- 3. The Counselor Supervisor Evaluation will comprise fifty percent (50%) of the counselor-in-training's final grade.
- 4. The Practicum course shall be conducted online and facilitated by Practicum Supervisors from LiSQuP.
- 5. The List of LiSQuP PhD Scholars Enrolled in DC 808 is attached, for your reference.
- 6. In this regard, Regional Offices and Schools Division Offices are requested to extend assistance to the concerned scholars through deloading of work and/or providing applicable means of support during their practicum/internship so they can complete the requirement and finish the course. Given that LiSQuP is a customized program, the practicum schedule cannot be adjusted.
