

PARTNERSHIP WITH NESTLE PHILIPPINES, INC. AND GREATFIL TEAM, INC.

- 1. Pursuant to the thrusts of the MaTaTaG Curriculum that include physical and mental well-being towards holistic education, the Department of Education National Capital Region (DepEd-NCR) has forged a Memorandum of Understanding (MOU) with Nestle Philippines, Inc. (NPI) and Greatfil Team, Inc. (GTI) to implement the Nestle Wellness Campus Program School Year 2024-2025 which aims to enhance the learners' health and wellness alongside their academic development, through incorporating various health and wellness activities and educational materials.
- 2. The program focal persons at the Division level are the MAPEH and TLE Education Program Supervisors to handle the contests, and the Senior Education Program Specialists for Social Mobilization and Networking for the partnership. The aforementioned focal persons shall collaborate with NPI and GTI for technical assistance and integration of the program into the curriculum.
- 3. In this connection, the Nestle Wellness Campus Program School Year 2024-2025 will be launched on **August 15, 2024, 9:00 A.M.** at the **DepEd NCR Conference Hall**, to be attended by the *Regional Office officials.*, *Schools Division Superintendents*, and *Division MAPEH and TLE Education Program Supervisors*.



MEMORANDUM OF UNDERSTANDING

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Understanding ("Memorandum") is made and entered into by and among:

THE DEPARTMENT OF EDUCATION of the Republic of the Philippines, through its Regional Office at the National Capital Region, with offices at the DepEd-NCR Complex, Misamis St., Bago Bantay, Quezon City represented herein by JOCELYN DR ANDAYA, Director IV, hereinafter referred to as "DepEdNCR";

-and-

GREATFIL TEAM, INC., a domestic corporation duly organized and existing under and by virtue of Philippine laws, with office address at Brixton Hill Condominium, 552 T. Arguelles St., Sta. Mesa, Manila, represented in this Act by its President, **MR. PATRICIO GOC-ONG**, hereinafter referred to "**GTI**";

-and-

NESTLÉ PHILIPPINES, INC., a domestic corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with administrative offices at the Nestlé Center, 31 Plaza Drive, Rockwell Center, Makati City, represented in this Act by its Senior Vice President and Head of Corporate Affairs, **MR. JOSE T. UY III**, hereinafter referred to as "**NPI**";

Collectively they are referred to as "PARTIES".

RECITALS

WHEREAS, the **DepEd-NCR** is the lead government agency that formulates, implements, and coordinates policies, plans, programs and projects in the areas of formal and non-formal basic education and supervises all elementary and secondary education institutions under its jurisdiction;

WHEREAS, **DepEd NCR** believes that one way of fulfilling its mandate and functions in providing better delivery of basic education is to collaborate with other government and non-government organizations and other stakeholders for auxiliary resources;

WHEREAS, Republic Act No. 8525 (RA 8525), otherwise known as the "Adopta-School Act of 1998" was enacted to encourage private entities to assist in the delivery of better quality education to public schools in the country, particularly in the poverty-stricken provinces;

WHEREAS, DepEd NCR in line with the policy enunciated under Joint Memorandum Circular 2010-01 issued by the Civil Service Commission and the Department of Health, and DepEd Order No. 6, s. 2012 and DepEd Order No. 48, s. 2016, does not deal with the tobacco industry, except to the extent strictly necessary to effectively regulate the tobacco products;

WHEREAS, DepEd NCR's top five (5) priorities are: (1)Keep school age children in school, (2)Improve foundational skills of learners, (3)Capacitate School Heads and teachers, (4)Ensure learner-centered environment, and (5)Strengthen governance.

WHEREAS, **NPI**, through its Corporate Affairs Department, will provide a school-based wellness program entitled the "SY 2024-2025 Nestlé Wellness Campus" (the "**Project**" or the "**Program**") which shall be organized and implemented through and with the assistance of GTI;

WHEREAS, NPI aims to collaborate with DepEd-NCR to improve the foundational skills of learners and foster learner-centered environments by providing learning resources and organizing inter-school activities while promoting nutrition, health and wellness, ultimately contributing to the development of stronger and healthier students.

WHEREAS, **DepEd-NCR**, **NPI** and **GTI** desire to collaborate for the successful implementation of the Project in all DepEd-NCR Junior High Schools, Senior High Schools and Public Elementary Schools located in the National Capital Region from 1 May 2024 to 31 March 2025;

NOW, THEREFORE, the **PARTIES** hereby set out the terms and conditions under which this partnership will be governed.

- 1. **NPI**, with the assistance of **GTI**, has established and intends to implement the Project, a program that aims to educate public high school and elementary students located in the National Capital Region on nutrition, health and wellness to establish healthier eating, drinking and lifestyle habits. The Project shall be organized and conducted pursuant to the Program mechanics attached hereto as **Annex "A"**.
- 2. **NPI** shall have the following obligations:
 - 2.1. **NPI** will provide learning resources on nutrition, hygiene, physical activity, and solid waste management for public elementary and junior high schools.
 - 2.2. Create, produce, and timely provide the following learning resources required for the Project, after securing approval from the **DepEd NCR** through Curriculum and Learning Management Division:
 - a. Educational videos and worksheets on nutrition and physical activity topics, tailored according to key stages
 - b. Modules on hygiene and solid waste management
 - c. Educational videos on nutrition for parents
 - d. Dancercise music

- 2.3. In collaboration with **DepEd NCR** through Curriculum and Learning Management Division and external experts, develop a validated tool that will help assess the knowledge, attitudes, and behavioral intention of food and nutrition habits among the learners following the implementation of the Project's learning resources.
- 2.4. To provide timely and effective media amplification for the Project on print, TV and digital (web and/or internet-based) media.
- 2.5. Through **GTI**, invite public school teachers and parents to join the Nestlé Wellness Campus Facebook communities.
- 2.6. Organize the inter-school contest and other wellness-related events like webinars, cooking demos and Nestlé-sponsored activities.
- 3. The **DepEd-NCR** shall have the following obligations:
 - a. Provide guidance and technical advice to the sixteen (16) Divisions to ensure proper implementation of the project;
 - b. Monitor the implementation for impact and outcome evaluation;
 - c. Coordinate and assist **GTI** and **NPI** in monitoring the implementation of the project;
 - d. Coordinate with GTI and NPI on the conduct of impact research of the project to secure recommendation from results of the study; and
 - e. Accept and facilitate the distribution of provided (DepEd-approved) learning resources.
 - 4. NPI with GTI shall have the following obligations:
 - a. Secure content approval of **DepEd NCR** before distribution of created learning resources;
 - b. Co-manage the supervision of the project with **DepEd NCR**;
 - c. Handle logistics needs and concerns of the project; and
 - d. Responsible for the proper and timely execution of the project.
 - e. Suggest and recommend on the progress of the Project moving forward based on final results provided that all obligations of the other parties had been fully carried out.
 - GTI shall have the following obligations:
 - 5.1. Manage and lead the implementation and monitoring of the project;
 - 5.2. Organize meeting alignment and updates pertaining to the Program with **NPI** and **DepEd-NCR** stakeholders;
 - 5.3. Organize and manage Facebook Messenger groups pertaining to the Program;
 - 5.4. Manage photo and video documentation and facilitate media interviews based on the direction of **NPI** and budget allocation;
 - 5.5. Handle logistics for the Project;
 - 5.6. Responsible for the proper and timely execution of the Project, the distribution of the learning resources, tokens, prizes and other giveaways

6. The **PARTIES** understand and agree that:

- 6.1. Their representatives to this Memorandum are duly authorized to sign the same and to bind the organizations to the terms and conditions thereof;
- 6.2. For any and all articles, endorsements, press releases and communication materials in connection with the Project or the Parties' involvement in the Project, **NPI** and **DepEd-NCR** must be duly acknowledged. Moreover, no such article, endorsement, press release or communication material shall be made without the prior approval of both **NPI** and **DepEd-NCR**;
- 6.3. All rights to the Nestlé Wellness Campus modules and wellness dancercise music specified in Clause 2 of this Memorandum belong to NPI. The wellness song, modules, or any portion thereof, can be copied, reproduced, transmitted, uploaded or otherwise used only with the express written consent of NPI, or if the same were already distributed to the public schools;
- 6.4. **NPI** and **GTI** shall be allowed to record any portion of the Project and to use the same in communications material of **NPI** for television, print and/or internet/web-based media provided that consent of the individual/s that will be involved were sought;
- 6.5. The Project shall not be entered into any competition, contest, recognition ceremony, publication or other similar event and publications without the prior consent of both NPI and DepEd-NCR. At such events, the Parties shall ensure that both NPI and DepEd-NCR are properly acknowledged;
- 6.6. The **PARTIES** shall not use each other's logos and/or trademarks on any press releases or communication materials without each other's written approval;
- 6.7. The **PARTIES** shall adhere to and promote Philippine laws safeguarding the rights of children and the Convention on the Rights of the Child (CRC), in which the best interest of the child is the primary consideration. Both Parties shall transact only with companies with existing national labor laws and regulations as regards their employment practices (minimum age of employment, wages, working conditions), including apprenticeships for children beyond the age of primary schooling;
- 6.8. Likewise, both **PARTIES** agree to abide by the basic principles of gender equality and comply with the provisions of existing gender-related international conventions and national laws. Specifically, both Parties shall ensure that no gender-based discrimination takes place in the course as part of this engagement, both Parties shall promote gender-

sensitive language, including but not limited to promotional materials, recordings and publications;

- 6.9. Both **PARTIES** shall follow the 2009 Department of Education Order No. 72 defining inclusive education as the philosophy of accepting all children regardless of race, size, shape, color, ability or disability with support from school staff, students, parents and the community;
- 6.10. All **PARTIES** shall comply with Republic Act No. 8293, otherwise known as the Intellectual Property Code of the Philippines;
- 6.11 All data of information belonging to or provided by **DepEd NCR** should be protected and shall not be used without the express written consent of **DepEd NCR** during the term and even after the termination of the Agreement, thus the data and information should be in compliance with the confidentiality and privacy requirement enshrined under Section 4 of Republic Act No. 10173, otherwise known as the "Data Privacy Act of 2012".
- After the duration of the Project, as specified in **Annex "A"** of this Memorandum, the rights of the parties over the output of the Project shall be as follows:
 - 6.1. Contest submissions and photo video documentation of the Project shall jointly belong to the **DepEd-NCR** and **NPI**. It is the responsibility of **DepEd-NCR**, through the schools, to obtain consent of the parents/guardians of the participating students in relation to the photo/video documentation of the event. It is the responsibility of **DepEd-NCR**, through the schools, to obtain the consent of the parents/guardians of the participating students in relation to the photo/video documentation of the event. Either party shall be free to use the same in connection with the Project without prior permission from the other. Where use shall be purposes outside of the Project, the other party's prior consent shall be obtained in writing.
 - 6.2. The copyright over the research specified in Clause 2.6 hereof shall belong to NPI. DepEd-NCR may make use of these materials, provided prior consent is given by NPI, which shall not be unreasonably withheld, and the copyright of NPI is acknowledged on the materials of DepEd-NCR. DepEd-NCR will be provided with a copy of the materials and may use the same for policy formulation with acknowledgment on NPI.
- 8. **NPI** and **DepEd-NCR** shall hold each other free and harmless from any and all claims made or filed by any person arising from any loss, damage, injury, or fault or misconduct committed during or on occasion of implementation of the Project.
- 9. The **PARTIES** hereby acknowledge that, in the course of carrying out their obligations and duties in connection with the Project, they, their employees, agents or representatives, may receive from, or be furnished by or on behalf

of, the Project Implementers information of a confidential nature (the "Confidential Information"). The **PARTIES** acknowledge an obligation to limit their disclosure of Confidential Information to those persons with a legitimate need to know and only under conditions of confidentiality. The **PARTIES** further agree not to exploit the Confidential Information except to use the same for purposes contemplated under this Memorandum.

The obligations of confidentiality and restricted use shall not apply to Confidential Information which:

- 8.1. is already in the public domain or within public knowledge prior to the execution of this Memorandum;
- 8.2. is required to be disclosed under any applicable law or regulation or any judicial order, provided that, in such event, the receiving party shall:
 - a. give the disclosing party immediate written notice thereof (including the manner of disclosure required) as soon as reasonably practicable, together with a written legal opinion confirming the required disclosure, unless such notice is prohibited under such law, regulation or judicial order; and
 - b. not affect any disclosure that is more extensive than that required by such law, regulation or judicial order and take all reasonable actions to seek confidential treatment of the Confidential Information disclosed.

This Memorandum is entered into on a fair and arms-length basis. Each party warrants that it has not given any gift, consideration, commission, reward, grant or endowment, to any officer, employee or representative of the other parties in connection with the negotiation, signing or implementation of this Memorandum; nor has entertained any solicitation for any such gift, consideration, commission, reward, grant or endowment in connection with the negotiation, signing or implementation of this Memorandum.

- 10. After this Memorandum terminates or expires, the terms and conditions that expressly or by their nature contemplate performance or observance after the termination or expiration of this Memorandum shall survive and continue in full force and effect until completely performed or observed.
- 11. This Memorandum is the whole agreement between the parties hereunder. No amendment of any of the foregoing terms and conditions shall be considered as having been made unless executed in writing and duly signed by the parties.
- 12. Should any provision or portion of this Memorandum be declared illegal or void by any future legislation or duly constituted authority, the other provisions or portions not so declared shall remain in full force and effect, without either party becoming liable to the other therefore.

- 13. This Memorandum shall commence from the execution and shall be valid and effective until 31 March 2025. DepEd-NCR and NPI may terminate this Memorandum at any time with thirty (30) days prior written notice to other parties.
- 14. This Memorandum shall be governed by the laws of the Republic of the Philippines. In the event of any issue or dispute arising out of or in connection with this Memorandum, the parties shall, in all cases, endeavor to settle the issue or dispute amicably. Nothing herein however, shall prevent the parties from submitting any issue or dispute to preventive mediation or arbitration as the case may be. In case of failure to reach an amicable settlement between the parties, as herein provided, either of the parties may resort to appropriate judicial action/s which shall be brought before the proper courts of Makati City, Metro Manila, to the exclusion of all other courts.

who will appoint the Division Supervisors or other DepEd officials to ensure that the Program will be implemented in all schools in their respective divisions in both elementary and high school levels. Division Supervisors or those appointed by the DepEd Regional Office in coordination with the Division Office will also be the contact persons in their respective divisions.

The S.Y. 2024-2025 Program implementation will give more emphasis on developing the students and parents' healthier habits through nutrition education, physical activity, and solid waste management. The Nestlé Wellness Campus Facebook Communities will serve as a platform for inter-school competitions, a repository of modules, music, and videos, and a space for parents and teachers to share wellness ideas and practices. Additionally, webinars, cooking demos, and Nestlé-sponsored activities will be conducted on these digital platforms.

The implementation of the Program will be in three (3) parts, as follows:

Part 1: NUTRITION EDUCATION FOR ELEMENTARY, JUNIOR HIGH SCHOOL STUDENTS AND ADULTS (Teachers and Parents) IN ALL PUBLIC SCHOOLS IN THE EIGHT (8) PARTICIPATING REGIONS.

- NPI, in collaboration with GTI, will provide modules in the form of video content. These videos are encouraged to be integrated into the Elementary and High School MAPEH curriculum, in accordance with DepEd rules and regulations.
- 2. Video modules will also be made available for parents, which can be utilized during PTA meetings or other face to face sessions in school. These modules aim to educate parents about the significance of good nutrition, maintaining a balanced diet, and understanding food labels.
- 3. Worksheets and activities are provided for students and/or parents to read and work on together, either at home or in the classrooms whenever feasible.
- 4. To ensure smooth program implementation, NPI, through GTI, will provide soft copies of the following materials to both division supervisors and MAPEH school coordinators:
 - 1. Lesson guides
 - 2. Videos of the modules
 - 3. Worksheets
 - 4. Contest Mechanics
- 5. For faster distribution, they may also get a copy of the materials through the GTI representatives.

Part 2: NESTLÉ WELLNESS CAMPUS DANCERCISE

Part 3: SY 2024-2025 NESTLÉ WELLNESS CAMPUS CONTESTS AND RECOGNITION

The current school year marks the 12th year of the Nestlé Wellness Campus program. NPI, through GTI, aims to make the program more fun and exciting through different competitions, allowing students, teachers, and parents to apply the knowledge gained from the provided modules. Winners who excel in these competitions will receive well-deserved recognition, while also contributing scores that will contribute to their respective regions' success.

The competitions will have three (3) categories, namely:

- A. Inter-school Category
- B. Inter-division Category
- C. Inter-region Category

A. INTER-SCHOOL CATEGORY

- 1. The inter-school category is open only to all public schools in both elementary and high school in the eight (8) participating regions namely:
 - National Capital Region (NCR)
 - ii. Region 4-A CALABARZON
 - iii. Region 5 Bicol Region
 - iv. Region 6 Western Visayas
 - v. Region 7 Central Visayas
 - vi. Region 8 Eastern Visayas
 - vii. Region 10 Northern Mindanao
 - viii. Region 11 Davao Region
- 2. Schools are strongly encouraged to participate in all categories. Interested schools must submit the registration form and ensure that students have duly signed the consent waiver form to confirm their participation. The inter-school competitions are as follows:
 - i. Nestlé Wellness Campus Hataw Sayaw Year 2
 - ii. Nestlé Wellness Best Implementing Schools
 - Sarap Sustansya Cook Off Competition (Junior High School only)

4. Each school is permitted to submit only one (1) entry for each competition. However, integrated schools have the opportunity to submit two entries: one (1) for the elementary level and one (1) for the junior high school level. The Sarap Sustansya Cook-off, on the other hand, is exclusively for the Junior High School level.

B. INTER-SCHOOLS DIVISION CATEGORY

The school year 2024-2025 marks the second year of the NWC Program's implementation of the inter-division competition, aimed at recognizing the Schools Division that demonstrates excellence in program implementation.

The Inter-Schools Division Category will have two levels as follows:

- o Regional level
- o National level

In the regional level competition, the winner will be determined based from implementation of NWCP in the division and the performance of the schools representing the division. The winning division will be declared the Outstanding Schools Division of the Year and correspondingly the focal person assigned will be declared the "Outstanding Focal Person of the year".

In the national competition, only the division with schools representing the region to the National level competition will qualify. The top three (3) divisions will be chosen based on the program implementation and scores gained by their schools representing the region. The division focal persons of the top three divisions will be declared the National Outstanding Division Focal Person of the Year, First-runner up and second runner-up respectively.
