The Learner Rights and Protection Office was mandated to ensure that all learners in the Philippines are protected from different forms of violence, exploitation, discrimination, bullying, and other conditions prejudicial to their development. The Training on Learner Rights and Protection Committee for Batch 2 aims to achieve the following objectives:
  - a. Identify and understand their roles in handling bullying incidents;
  - b. Develop intervention programs for bullying incidents;
  - c. Proper handling of learners involved in bullying - the bully, the victim, and the bystanders;
  - d. Referral system on severe cases of bullying; and
  - e. Enforce a rights-based approach to bullying.
3. This event is scheduled to take place from August 19 to 23, 2024, at Baguio Teachers Camp, Baguio City. Participants are required to check in on August 19, 2024, Monday, at 2:00 PM, and check out on August 23, 2024, Friday, by 12:00 PM. Additionally, due to the special non-working holiday on August 21, 2024, the LRPO will provide participants with Compensatory Time Off (CTO).
