

The Department of Education (DepEd), in coordination with the Philippine Sports Commission (PSC) and the Department of Interior and Local Government (DILG), shall conduct the **64th edition of the Palarong Pambansa from July 06 to 17, 2024 in Cebu City.**

In regard thereto, this Office hereby issues the **2024 Palarong Pambansa Organizational Structure** – containing the list of members of the *Palarong Pambansa* Board, National Executive Committee, Steering Committee, and various technical working committees under the Management Working Committees (MWCs) – and the **List of Technical Officiating Officials** of the different sports events to be featured in the annual scholastic multi-sport competition.

The members of the MWCs and the technical officiating officials shall register on **July 06-07, 2023** at the **Cebu City Sports Center** (formerly known as Abellana Sports Complex). The required documents stated in DM 35, s. 2023, Item 6 shall be submitted upon registration.

The following documentary requirements shall be presented by the selected officiating officials upon registration:

a. Authority to Travel documents:

- i. For DepEd employees – approved travel authority duly signed by their respective heads of office;
- ii. For national sports association (NSA) members – official letter from the Association President or Secretary General (or any NSA duly authorized official) authorizing their participation;
- iii. For those coming from the host local government unit (LGU) – letter of endorsement from the Local Chief Executive or City/Provincial Administrator or authorized official in charge of *2024 Palarong Pambansa*; and
- iv. For Philippine Sports Commission (PSC) employees – official Travel Order from the PSC Executive Director.

b. Two (2) recent 2" x 2" ID pictures; and

- c. Medical certificate issued by a government physician certifying that he/she is physically fit and able to serve during the *Palarong Pambansa*.**

Failure to submit all abovementioned documents shall be grounds for denial of registration.

All selected technical officiating officials **are required to attend the opening and closing programs** of the *2024 Palarong Pambansa*, and the **Refresher Course**. The Technical Management and Administration Committee shall replace those technical officiating officials who fail to register and attend the Refresher Course.

DepEd teaching personnel who will serve in the *2024 Palarong Pambansa* as accredited technical officiating officials or member of the various national and regional working committees shall be entitled to all financial subventions such as meal expense and other subsidies authorized by this Department, subject to the usual government accounting and auditing rules and regulations.

Further, all aforementioned personnel shall be granted vacation leave credits pursuant to the provisions of DepEd Order No. 53, s. 2003 entitled *Updated Guidelines on Grant of Vacation Service Credits to Teachers*.

As a reiteration, all members of the MWCs and the technical officiating officials shall strictly observe the **No Alcohol, No Smoking, and No Gambling Policy** of this Department for the duration of the *2024 Palarong Pambansa*. Violators shall be dealt with accordingly.
