DATE : August 14, 2024

The Department of Education, through the Bureau of Curriculum Development-Curriculum Standards Development Division (BCD-CSDD), shall conduct the **Consultation Workshop with the Experts and Industry and International Benchmarking on the SHS Model/Framework and Structure** on **August 26-30, 2024**, at the venue within NCR, to be announced on a separate issuance.

This activity aims to:

1. determine the alignment of the senior high school structures with evolving industry demands and technological advancements, aiming to enhance students' readiness for the rapidly changing workforce; and
2. review the draft Senior High School Frameworks for curriculum revision.

In this regard, Supervisors/SHS School Heads/Focals/Coordinators are requested to participate in this activity. Each region shall send **seven (7) participants** representing SHS tracks and strands, e.g., Academic (STEM, HUMSS, ABM), TVL, Sports, and Arts and Design. For the schedule of activities, please refer to the attached activity matrix.

Board and lodging, supplies, materials, and travel expenses of participants shall be charged against 2023 BEC Continuing Funds. In case the downloaded funds are insufficient, additional funds shall be obtained from other available local funds subject to usual auditing and accounting.
