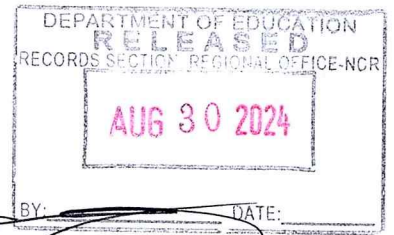

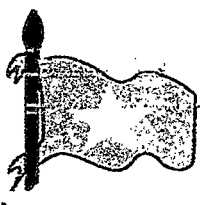

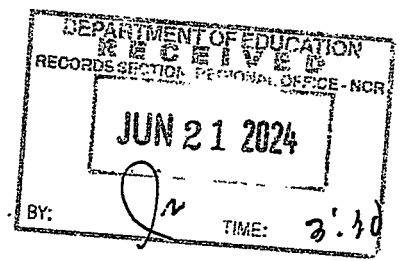

Greetings from the Bureau of Jail Management and Penology – NCR!

One of the core programs of the Bureau of Jail Management and Penology is the literacy program that aims to provide opportunities for persons deprived of liberty (PDL) to achieve mandatory education. The jail bureau adopted the Alternative Learning System (ALS) of the Department of Education (DepEd) for the PDL to earn their elementary, junior, and senior high school diplomas.
