 - a. Printed copy of Test Permit;
 - b. Printed copy of the Comprehensive Examination with examinee number;
 - c. Evaluation Form signed by the University Registrar;

- d. Philippine Normal University LiSQuP notification email (for further verification); and
- e. Proof of attendance in the Comprehensive Examination (post-exam, as needed).
- 4. School Heads of the concerned teacher-scholars shall make necessary arrangements to ensure that the *No Disruption of Classes Policy* will be strictly observed. Likewise, Heads of Office of concerned school head/supervisor-scholars shall ensure that office operations and efficiency will not be hampered in the provision of support and consideration.
