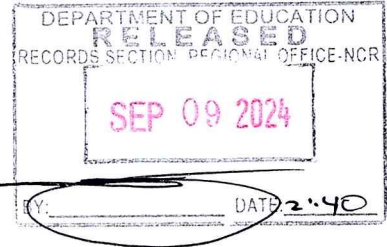

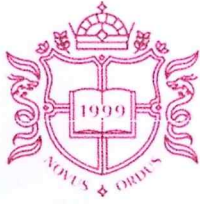

Warm greetings from Thames International!

Last August 1, 2024, the Memorandum of Agreement (MOA) for the implementation of the E-Commerce SHS Track was signed between the Department of Education (DepEd), Department of Trade and Industry (DTI) and Thames International School. DepEd Sec. Sonny Angara is in full support of this MOA and its implementation starting SY 2024-2025 specifically for NCR, Region 3 and Region 4A.

Just to recap what we have presented last August 27, 2024 meeting with SDOs and pilot schools, we aim to achieve the following for NCR:

SHS Ecommerce SY 2024-2025: 800-1600 students

- 2 schools per SDO for 25-50 students each
  - a. 16 Cities/SDOs, 1 pilot school each from 2020 pilot run
  - b. 16 Cities/SDOs, 1 additional school from each, especially those schools who have problems with congestion
- Learner Applications and Enrolment extended up to Sept. 15, 2024.

Part of the responsibilities Thames under the MOA and its implementation is to conduct the promotion and recruitment of learners for the program. Likewise, DepEd will facilitate these activities, including the support in selecting the schools. To ensure a successful program launch, we respectfully request your support in facilitating and authorizing our promotional activities within NCR schools. Additionally, we would appreciate the designation of focal persons from the Region and SDOs for direct coordination. Thames is also open to conduct another briefing for the SDOs and identified schools before the actual roadshows.

  - a. Venue
  - b. Gather eligible students for the program, based on the following criteria:
    1. With at least 85 GWA in Grade 10
