I am writing to inform you about two important upcoming visits to Khan Academy partner schools happening this month.

The first will take place on **September 10, 2024**, at Fernando Ma. Guerrero Elementary School in the City of Manila. This visit has been requested by the **Office of Secretary Angara** and will involve members of the DepEd Executive Committee, including several undersecretaries and assistant secretaries. The delegation will observe a Grade 5 Khan Academy session, providing an authentic view of how the program is integrated into daily classroom activities.

The tentative flow of events for September 10 is as follows:

- 2:00 PM: Members of DepEd delegation arrive at school for Khan Academy briefer
- 2:15 PM: Classroom observation with informal Q&A
- 3:00 PM: Classroom observation concludes, followed by debrief
- 3:30 PM: School visit concludes

The second visit is scheduled for **September 17, 2024**, and will involve international visitors from Singapore. They are interested in observing the implementation of the Khan Academy program across two schools, Guadalupe Viejo Elementary School in Makati City and President Corazon Aquino Elementary School in Quezon City. This will offer them insight into the impact of Khan Academy on student learning.
