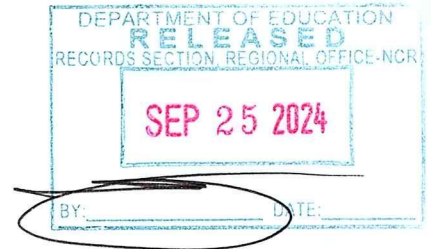

Pursuant to Department of Education (DepEd) Order No. 31, s. 2022 or the "Child Rights Policy: Adopting the Rights-Based Education Framework in Philippine Basic Education", which embodies DepEd's strong resolve to respect, protect, fulfill, and promote the rights of children in basic education, the DepEd Learner Rights and Protection Office (LRPO) has partnered with the Geneva Office for Human Rights (GO-HRE) aims to provide an in-depth discussion on the developed "Teaching Manual on Children's Rights" providing a clear and achievable activity for teaching our learners about human rights, with emphasis on their corresponding duties and responsibilities as rights-holders.

Relatedly, last April 22 – 25, 2024 the LRPO and GO-HRE conducted the first batch of the Orientation on the Implementation of the Teaching Manual on Children's Rights at Baguio Teachers Camp, Baguio City, while its second batch was conducted last August 6-9, 2024 in Cebu City. During the first and second batch of the orientation, our participants experienced first-hand the use of the Manual and acquired tools on how to cascade the lessons to our learners through an in-depth discussion of its application in crafting a lesson exemplar.

For the Batch III, our goal is to develop lesson exemplars specifically to address the issues on bullying, developing empathy and kindness among learners, and children's rights. In line therewith, may we request the regional heads to identify their respective representatives from the region who will serve as participants for the third batch of our orientation. Considering that

the discussion and corresponding activities will focus on learner rights and their integration into the curriculum, may we request that the selected participants be either:

1. Regional or Division Learner Rights and Protection (LRP) Focal Person;
2. Representative from Curriculum Implementation Division (CID)
3. Education Program Supervisor for ESP
4. School Head; and
5. Registered Guidance Counselor (RGC) or Guidance Coordinator/Designate
