



# APPLICATION GUIDE FOR MASTER OF ARTS IN EDUCATION MAJOR IN CHINESE LANGUAGE TEACHING (MAED CLT) SCHOLARSHIP ACADEMIC YEAR 2024-2025 (MAED CLT BATCH 5)

For the purpose of cultivating highly qualified Chinese language teachers for the Special Program in Foreign Language-Chinese Mandarin (SPFL-CM) of the Department of Education of the Philippines, the Confucius Institute Headquarters, through Angeles University Foundation and Fujian Normal University, will offer a scholarship program for Master of Arts in Education major in Chinese Language Teaching (MAEd CLT).

The implementing schools of SPFL-Chinese may recommend outstanding currently-employed local Chinese language teachers to study MAEd CLT in AUF & FNU.

### PROGRAM DESCRIPTION:

Master of Arts in Education major in Chinese Language Teaching (MAEd CLT) is a two-year program which aims to develop competent and effective teachers of Chinese as a foreign language.

### **ELIGIBILITY**

All applicants shall be:

- non-Chinese citizens;
- committed to teach the Chinese language under DepEd's Special Program in Foreign Language;
- between the ages of 20 and 35;
- HSK 2 (CEFR A2) level of Chinese language proficiency;
- Must pass AUF Admissions requirements (please refer to https://auf.edu.ph/modules.php?n=Articles&t=admission)

\*For this academic year, MAEd CLT will be offered to all teachers of SPFL-Chinese Mandarin, regardless of their region. Official list of qualified applicants will be released in subsequent memorandum.

### SCHOLARSHIP COVERAGE

The program commences in August 2024. The study plan covers a maximum of two academic years- 4 trimesters in AUF and 2 trimesters in FNU.

The scholarship program shall provide the following:

- AUF (Tuition and Miscellaneous Fees for 4 trimesters)
- FNU (Accommodation, Health Insurance, 18,000 RMB food and transportation allowance for 2 trimesters)

### MODE OF DELIVERY

Online instruction through AUF MyClass, AUF's learning management system.

<sup>\*</sup>Students must pass HSK 3 before the 6-month immersion program in FNU, China.

### APPLICATION PROCEDURES

- Step 1: CI-AUF facilitates registration of interested applicants.
- Step 2: CI-AUF forward list to DepEd for initial screening.
- Step 3: Screened applicants will submit their Documentary Requirements to DepEd CO.
- Step 4: Screened applicants will submit their Documentary Requirements to AUF Graduate School.
- Step 5: Qualified applicants register and enroll in the AUF Graduate School.
