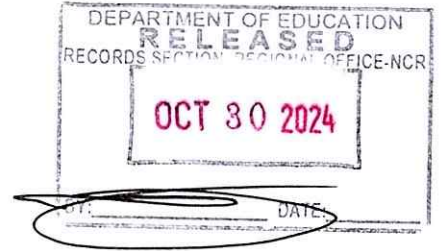



1. The Teacher Education Council (TEC) officially approved the conduct of the pre-service teacher education curriculum review during its 3<sup>rd</sup> Quarterly Meeting (QM) on October 9, 2024.
2. This initiative is pursuant to the Republic Act 11713, or the *Excellence in Teacher Education Act*, where the TEC is mandated to “**set and mandate basic requirements for teacher education programs, monitor and quality assure compliance therewith** to ensure a strong and transparent link between the outcomes of teacher education programs and the professional standards for teachers and school leaders, research, and international best practices. It shall likewise ensure that such minimum requirements are implemented by the CHED” (Section 8, c).
3. In this regard, the **information on the plans for pre-service teacher education curriculum** as presented during the TEC 3<sup>rd</sup> QM is provided for your reference (see Annex A).
4. In this regard, the TEC has launched initiatives/activities for this purpose. One of them is the **national survey** that aims to solicit the collective perspectives of various stakeholders, including **in-service teachers, school leaders, students and parents’ opinions**, regarding the pre-service teacher education curriculum in the country. **It is requested that this survey be disseminated within your jurisdiction to engage your stakeholders in the ongoing curriculum review by sharing through your official platforms. 
