

The selected LREs are reminded of the following:

- 1. Digital copies of the assigned materials shall be accessed through a One Drive for online evaluation and writing of marginal notes;
- 2. Guidelines in the Content and Language Evaluation which shall be used to prepare their marginal notes may also be accessed in the One Drive link;
- 3. Certificates of Recognition will be awarded to the participants for serving as LREs in this activity;
- 4. Service credits or compensatory time-off (CTO) computed against the actual days they served as LREs may be requested in accordance with Civil Service Commission & DBM Joint Circular No. 2, s. 2004 rules and regulations; and
- 5. Learning Resource Evaluators have the option to transition from work-fromhome arrangement to evaluate assigned lesson exemplars and learning activity sheets upon the approval of their immediate supervisors.

To minimize disruption during the online quality assurance workshop, teachers will adopt blended learning strategies. Alternatively, relievers may be assigned to manage their classes. Teachers will complete their assigned tasks after teaching hours, which can be used as service credits.
