
CONDUCT OF PROFESSIONAL DEVELOPMENT LEARNING AND DEVELOPMENT NEEDS SURVEY AND FOCUS GROUP DISCUSSIONS (FGDs) OF THE REGIONAL PROGRAM MANAGEMENT TEAM FOR THE PROFESSIONAL DEVELOPMENT PROGRAM OF CHIEF EDUCATION SUPERVISORS

- 1. In adherence to the DepEd NCR Competency-Based L&D Plans and Guidelines, it is recommended that Chief Education Supervisors (CES) officials include four (4) planned interventions per year focusing on enhancing the developmental continuum of professional practice that supports supervisors in the conduct of their roles in the regions, divisions, and schools.
