SUPER TYPHOON (STY) "LEON"**

In compliance with the DepEd Order (DO) No. 21, s. 2015, titled "Disaster Risk Reduction and Management Coordination and Information Management Protocol," and DO No. 33, s. 2021, titled "School-Based Disaster Preparedness and Response Measures for Tropical Cyclones, Flooding, and Other Weather-related Disturbances and Calamities," the Office of the Undersecretary for Operations through the Disaster Risk Reduction and Management Service (DRRMS) reminds all affected field offices and schools to **maintain the activation of the Regional, Division, and School DRRM Teams and conduct effective and timely vetting of RADaR affected by the Severe Tropical Storm (STS) Kristine and/or Super Typhoon (STY) Leon.** The submission of RADaR by all affected schools must be done within 72 hours in the aftermath of the occurrence of the hazard.

In this regard, all affected Division Offices must submit the vetted RADaR to their respective Regional Office and the DRRMS on the following dates:

Hazard	Deadline of Submission of Vetted RADAR
STS Kristine	November 8, 2024
STY Leon	November 15, 2024

With the maintained activation of Division DRRM Teams of affected field offices, the Division DRRM Team, with the leadership of the Schools Division Superintendent as Emergency Responsible Official, should strategize to meet the deadline of submission (e.g., augmentation of DepEd personnel to the Division DRRM Team from within and outside the Division Office to expedite the validation/vetting of RADaR).

Furthermore, the DRRM Coordinators concerned shall facilitate the consolidation of vetted RADaR and the provision of needed response interventions to affected schools.

All vetted RADaR and reports on the response interventions provided shall be submitted to the DRRMS through email at drmo@deped.gov.ph, with a copy furnished to johnherbert.nieva@deped.gov.ph.
