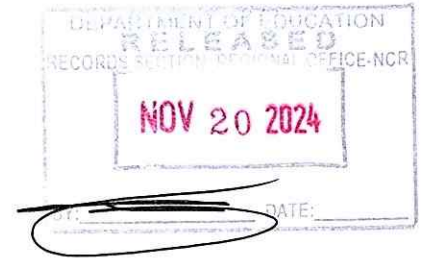

**ADMINISTRATIVE ARRANGEMENTS IN THE CONDUCT OF POST-EVALUATION
CUM CULMINATING ACTIVITY FOR THE FY 2023 NQESH SUCCESSFUL
EXAMINEES AND FY 2021 NQESH CATEGORY B COMPLETERS**

1. Relative to **Regional Memorandum No. 1162, s. 2024**, dated 04 November, 2024, titled "*Post-Evaluation cum Culminating Activity for the FY2023 NQESH Successful Examinees and FY2021 NQESH Category B Completers*," this Office informs the field of the above-captioned subject.
