

SUBJECT : **REVISED TECHNICAL SPECIFICATIONS FOR THE
PROCUREMENT OF TABLETS**

DATE : **November 13, 2024**

This is in reference to the Joint Memorandum titled “Guidelines on the Conduct of Early Procurement Activities (EPA) for FY 2025 for the Procurement and Delivery of Tablets” dated October 14, 2024.

In view of the new technical specifications provided by the Information and Communications Technology Service (ICTS), please be advised that the Minimum

Technical Specifications for tablets attached as Annex C on the above-mentioned Memorandum shall be amended to the following:

For purposes of procurement, “Manufacturer Documentary Proof” is explicitly defined as unamended manufacturer’s sales documents / literature including brochures, official online sources, or communication from the official email address of the brand manufacturer. These are considered documents under the column labeled “Evidence of Compliance” and should be submitted as proof of compliance during the bid opening.

The revision of the technical specifications has no substantial implication on the cost of the tablets.

Regional Office-Bids and Awards Committees (BACs) are instructed to issue any bid bulletin, when necessary, to reflect the revised specifications.
