In line with the Presidential Promulgation No. 417¹ and the Implementing Rules and Regulation (IRR) of Republic Act No. 11930², the Department of Education (DepEd) Office of the Undersecretary for Operations through the Learner Rights and Protection Office (LRPO) and the Office of the Undersecretary for Curriculum and Teaching, together with our partner, the Stairway Foundation, Inc. (SFI) aims to increase the awareness of programs addressing Online Sexual Abuse and Exploitation (OSAEC) and Child Sexual Abuse or Exploitation Material (CSAEM) in schools through the conduct a classroom-based learning session.

In time for the 2024 Safer Internet Day, the cybersafety session guide was rolled out in schools for K-10 learners. 
