- 1. In line with **Memorandum OUF 2024 0930** signed by **Annalyn M. Sevilla**, **Undersecretary for Finance**, dated November 14, 2024, the following private schools were found to have discrepancies between its Billing Statement and LIS Information:
  - a. St. Matthew Hospitality and Technology Institute Quezon City
  - b. Dr. Rosita B. Britanico Academy Inc. Caloocan City
- 2. Thus, this Office directs each division office to validate the identified discrepancies through the learners, teachers, school heads and other concerned personnel, and determine the private schools' source of data in terms of learner's name and LRNs.

This refers to the Government Assistance and Subsidies Service (GASS) ongoing initiative to validate the beneficiaries of the Senior High School Voucher Program (SHSVP) to ensure the accuracy and legitimacy of billing statements submitted by the private participating schools listed below:

- 1. St. Matthew Hospitality and Technology Institute (SMHATI) Inc.
- 2. School of St. Ignatius Inc.
- 3. Dr. Rosita B. Britanico Academy Inc.

As a result of the validation process, we identified discrepancies between the information in the billing statements and the Learner Information System (LIS), particularly regarding the abovementioned schools where the learners were reported to be enrolled (Attached as Annex A are the list of beneficiaries).

In view of the foregoing, we respectfully request your assistance in the following matters:

- Conduct an inquiry into the identified discrepancies by verifying the claims/allegations of the
  private schools that learners were enrolled in their schools during the time of billing against
  the statements to be gathered from the learners themselves, teachers, schools' heads, school
  division superintendents, and/or other concerned individuals; and
- 2. Ascertain how the schools obtained the names and Learner Reference Numbers (LRNs) of the learners.

In this regard, we respectfully request for your assistance on this matter, we appreciate receiving the result of your validation within seven (7) days upon the receipt.
