1. The Department of Education-NCR (DepEd-NCR) through the Curriculum and Learning Management Division – Learning Resource Management Section (CLMD-LRMS) and as assigned by the Central Office, will conduct the above-stated activity on the following dates and venues:

2. The Workshop aims to:

- Produce Grades 1,4 and 7 GMRC and VE ADM SLMs that are aligned with the principles and learning competencies outlined in the Enhanced K to BEC, and
- Ensure that the Grades 1,4 and 7 GMRC and VE ADM SLMs reflects contemporary Filipino values and moral principles that are culturally relevant and context-appropriate, and compliant to LRMS and ADM SLMs standards.

Participants to this series of workshops are the CLMD OIC and Education Program Supervisors, RO LRMS Head, SDO LRMS and GMRC/VE Education Program Supervisors, Project Development Officers II, writers, layout artists, illustrators, language specialists, and learning resource evaluators (LREs) as stated in the list that can be accessed using the link <https://tinyurl.com/K147GMRCVEADMSLMSTEAM>. They are required to do pre-registration using the same link on or before February 5, 2025.

5. Certification of Appearance shall be awarded at the end of each workshop, while Certificate of Participation/Appreciation shall be awarded at the end of the entire workshop and upon submission and checking of the completeness and correctness of the required outputs.
6. Participants are expected to be at the venue at 10:00 AM on February 10, 2025 for the onsite registration and distribution of workshop materials.
7. First meal of the activity is morning snacks of February 10, 2025, and last meal is afternoons snacks of February 14, 2025. Check in is at 2:00 PM of day 1, and check out is 12:00 Noon of day 5.
