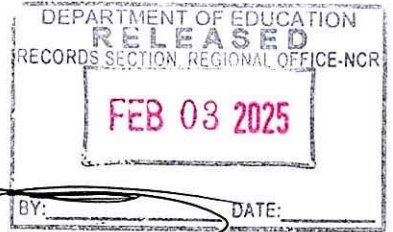

UPDATED SCHOOL MOOE WEB-BASED MONITORING SYSTEM USAGE

1. This has reference to the attached **MEMORANDUM OUF-2025-0045** dated January 22, 2025, regarding updates on the utilization of the School Maintenance and Other Operating Expenses (MOOE) Web-Based Monitoring System, a system for monitoring the release, receipt, and reporting of School MOOE funds of Division Offices in NCR.
2. As stated in the said Memorandum, only 14.06% or 116 out of 825 schools in 16 Schools Division Offices in NCR were reported to have encoded in the system as of December 19, 2024.
3. In view hereof, all SDOs are directed to monitor the utilization of the system by their Implementation Units to ensure 100% usage. **Memorandum OUF2021-0880** dated December 28, 2021, was issued for the adoption and implementation of the web-based monitoring system for School MOOE funds, while **Memorandum OUF-2023-073** dated December 18, 2023, reiterated the use and implementation of the system.

As of December 19, 2024, 14.06% or 116 out of 825 schools in your Region with budget uploaded in the monitoring system were reported to have used the system, the breakdown is provided in the table below.
