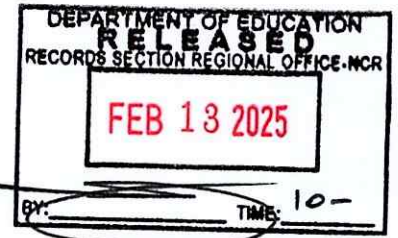

NATIONAL CAPITAL REGION**

This pertains to the implementation of the Joint Delivery Voucher Program (JDVP) in the School Year (SY) 2024-2025 in the DepEd National Capital Region (NCR).

This office was informed that DepEd NCR initially allotted 151 JDVP slots for learners in E-commerce. However, since the E-Commerce initiative is still under evaluation, it would be more prudent to prioritize the inclusion of learners from other Technical-Vocational-Livelihood (TVL) specializations who are already eligible for JDVP. This will ensure that current opportunities are maximized for those who can benefit immediately while allowing additional time for further study and assessment of the E-Commerce initiative before its potential inclusion in JDVP.

In this regard, this Office respectfully directs DepEd NCR to allocate **the 151 JDVP slots for SY 2024-2025 to other JDVP-TVL qualified learner beneficiaries.**
