

Pursuant to **DM-OUOPS-2025-11-00442**, titled "Learner Government Elections for School Year (S.Y.) 2025-2026," the Learner Government (LG) elections in all public elementary and secondary schools nationwide are set to be conducted from **February 12** to **28**, **2025**. This activity supports the mission of the Department of Education (DepEd) to amplify learners' voices in decision-making and the commitment to support learners in fostering leadership skills that contribute to their holistic growth and development.

The Department also acknowledges that it is imperative to monitor the implementation and operations of the Supreme Elementary Learner Government (SELG) and Supreme Secondary Learner Government (SSLG) as it is recognized as the foremost co-curricular, learner-led organization authorized to implement programs, projects, and activities in all elementary and secondary schools nationwide.

In line with this, the Operations Strand, through the Bureau of Learner Support Services-Youth Formation Division (BLSS-YFD) aims to conduct a field monitoring and evaluation during the school-based SELG and SSLG elections to the following regions from February 24 to March 1, 2025:

Specifically, this activity aims to:

 a. monitor at least 4-5 schools to systematically assess and evaluate the effectiveness and quality of their program implementation;

- facilitate a series of Focus Group Discussions (FGDs) with program implementers and learners; and
- c. conduct a comprehensive orientation session to outline the program's establishment, operational guidelines, and objectives, while actively gathering feedback from schools to identify specific needs for technical assistance and support, ensuring contextualized and effective implementation.

All expenses related to the conduct of this activity shall be charged against the available allotments, such as, but not limited to Operations of School - Maintenance and Other Operating Expenses (School MOOE), Program Support Funds (PSF) to be downloaded to the host region and division, and other available sources of funds, in accordance with existing budgeting, accounting, auditing, and procurement rules and regulations.

Moreover, all Regional Youth Formation Coordinators (RYFCs) of each identified region are hereby requested to attend the **Coordination Meeting** relative to the conduct of the said field monitoring and evaluation activity to be organized by the BLSS-YFD. The meeting shall take place on **Monday**, **February 17**, **2025**, from **10:00 a.m.** to **12:00 p.m.** via **Microsoft Teams**.
